**EDUCATIONAL NOTICE**

**ADMISSION TO THE MDS COURSE (ASSAM QUOTA) IN  
THE REGIONAL DENTAL COLLEGE, GUWAHATI, FOR THE SESSION 2013**

Applications are invited from the Dental Graduates belonging to the state of Assam for admission to the MDS course (Assam Quota) of Regional Dental College, Guwahati, for the session 2013. Interested candidates are hereby informed to collect Application Forms by paying Rs. 300.00 (Rupees Three hundred only) in the form of Bank Draft/Banker's Cheque in favour of “**Srimanta Sankaradeva University of Health Sciences**” payable at “**Guwahati**” from the Office of the Principal, Regional Dental College, Guwahati.

Application Forms will be issued on all working days during office hours from **16-01-2013 to 22-01-2013**. The last date of submission of filled in Application Form is **24-01-2013 (up to 4:15 PM)** which is to be submitted at the Office of the Principal, Regional Dental College, Guwahati.

Applicants or their duly authorized persons are informed to collect the Admit Cards from the Office of the Principal, Regional Dental College, Guwahati, on 28-01-2013 during office hours.

**The Entrance test will be held on 30-01-2013 from 10AM to 1PM.**

Admission into the courses is subject to the approval by Ministry of Health & F.W., Government of India, and Dental Council of India.

**Important:**

1. This Entrance Examination is being held in pursuance of Order passed by Hon'ble Supreme Court of India in Transferred Case (Civil) No. 101 of 2012 and many other similar transferred cases and Govt. of Assam order No. HLB.486/2009/197 dated Dispur the 24<sup>th</sup> December, 2012, Director of Medical Assam letter No. DME/MDS/22/98/Pt/469/ dated 5<sup>th</sup> January, 2013. The Hon'ble Court has passed the order saying that **the Medical Council of India, Dental Council of India, as well as the States and Universities and other Institutions will be entitled to conduct their respective examinations for M.B.B.S, B.D.S. and Post-Graduate courses, but shall not declare the results of the same, until further orders of the Court.** As such the result of the said Entrance Examination shall not be published until further orders by the Hon'ble Supreme Court of India.
2. This is for the information of all concerned that Mobile Phones and any other Electronic Gadgets are not allowed inside the Examination Hall. Candidates are requested not to bring any such items to the examination hall, possession of which will make him/her liable for expulsion from the examination. University will appoint observers to oversee the smooth conduction of the examination in addition to the invigilators. Candidates are also informed that Mobile Phones etc. will not be kept by the staff of the examination centers and shall have to keep them outside the examination hall at their own risk.
3. Consequent to the subsequent hearing and Order by the Hon'ble Supreme Court of India, if the examination has to be cancelled before it is held, 80% of the Examination Fee will be refunded by the University to the applicant. But, once the examination is held there shall be no refund of Examination Fee.
