It is for general information to all candidates appeared in Entrance Examination for admission into 1st year B.H.M.S. course held on 29th and 30th August 2015 under Srimanta Sankaradeva University of Health Sciences, Assam that the counseling for selection of candidates for provisional admission into BHMS course for the session 2015-16 **will be held on 27th October, 2015 at 10 A.M.** in the premises of SJN Homoeopathic Medical College & Hospital, Panjabari, Guwahati.

Candidates must bring with them **Form-B** in original duly and properly filled in along with a set of self attested photo copies as well as original copies of all relevant documents as per Form-B at the time of counseling. Criminal proceeding shall be drawn for submission of false documents at the time of counseling.

Application Form-B shall be available in the office of the Principals, SJN Homoeopathic Medical College & Hospital, Panjabari, Guwahati, Assam Homoeopathic Medical College & Hospital, Lakhinagar, Nagaon and Dr. JKS Homoeopathic Medical College & Hospital, Club Road, Jorhat with effect from 12/10/2015 to 15/10/2015 during office hour. Incomplete application Form-B shall be summarily rejected.

The candidates up to BHMSEE **rank of 130 under General (Unreserved), 515 under OBC/MOBC, 134 under Char Area and all candidates under all other categories including Schedule Cast, Schedule Tribe(P) and Schedule Tribe(H)** are to appear personally before Counseling-cum-Selection Board on the scheduled dates and time for provisional admission, subject to fulfillment of prescribed eligibility criteria.

The selection of candidates will be made in accordance of merit position of BHMS Entrance Examination, 2015. Candidates who fail to appear personally before the Counseling-cum-Selection Board will forfeit his/her merit position and seat and no claim shall be considered later. In case of any controversy, the decision of the Counseling/ Selection Board shall be final and binding. Candidates will have to deposit a sum of Rs. 500/- (five hundred) only as counseling fee during the time of counseling.
