1. Clause 3.1.5 be read as

Eligible Assignments

For the purposes of satisfying the Conditions of Eligibility and for evaluating the Proposals under this RFP, Consultancy /advisory assignments granted by the government, regulatory commission, tribunal, statutory authority or public sector entity in last 5 (Five) Years in respect of development of Infrastructure projects like Office complexes, Institutional complexes, Public utility spaces, Libraries, Auditorium etc. including their master planning, and preparation of bid documents and other related assignments in relation to the bidding process as the case may be, of at least Rs. 24 Cr (Rupees Twenty four crores) shall be deemed as eligible assignments (the "Eligible Assignments").

2. Clause 3.1.6 be read as

Other relevant assignments


Assignments undertaken by the Applicant/ Key Personnel for private sector entities shall be considered for evaluation if: (a) the advisory/ consultancy services relate to an infrastructure project; (b) the estimated capital cost of the project Rs. 24.00 Cr (Twenty-Four Crore) and (c) the professional fee for the assignment was at least Rs. 82.12Lakhs. (Rupees Eighty-Two Lakhs and Twelve Thousand only).

3. Proposed Site is uploaded in KMZ format on the website. Actual Site to be physically surveyed.

4. Total Area considered for Administrative Block is Approx. 10,000 M².


