**Educational Notice**  
**(No. EXAM/19/2023)**

This is for information to all concerned that Srimanta Sankaradeva University of Health Sciences in pursuance of Competency Based Medical Education Curriculum (CBME) Regulations 2023, National Medical Commission vide No.U.14021/8/2023-UGMEB, dated 01-08-2023 and CBME Guidelines – National Medical Commission (Corrigendum) F.No.U/14021/8/2023-UGMEB, dated 01-09-2023, hereby notifies the following:

**University Examinations:**

**A. No grace marks will be awarded for passing in an examination.**

**B. Passing criteria in a subject:**

1. A candidate has to obtain 50% marks in aggregate in University conducted examination (Theory and Practical combined) and 40% (minimum) separately in Theory and Practical i.e. 40:60 in Theory : Practical or 60:40 in Theory : Practical in order to be declared as passed in the subject. Practical examination includes practical/clinical and viva-voce.
2. In subjects that have two papers, the candidate must secure minimum 40% of marks in aggregate (both papers together) to pass in the subject.

**C. Appointment of Examiners:**

1. A person appointed as an examiner in the particular subject must have atleast four years of total teaching experience as Assistant Professor after obtaining postgraduate degree following MBBS in the subject in a college affiliated to a medical college recognized by UGMEB of NMC.
2. All eligible examiners with requisite qualifications and experience can be appointed as internal examiners by rotation in their subjects.



3. For Practical / Clinical examinations, there shall be atleast four examiners for every learner, out of which 50% must be external examiners. Of the four examiners, the senior most internal examiner shall act as the Chairman and Coordinator of the whole examination programme so that uniformity in the matter of assessment of candidates is maintained.
4. The internal examiners will be from the concerned college. The external examiner may be from outside the College/ University/ State/ Union Territory.
5. The Examiners for General Surgery and allied subjects and for General Medicine and allied subjects shall be only from General Surgery and General Medicine respectively. For all other matters, please refer to the CBME Regulations, 2023 – National Medical Commission No. U.14021/8/2023-UGMEB, dated 01-08-2023.
