Applications are invited in the prescribed format (Available in University Website www.ssuhs.in) for appointment on honorary basis to the post of Dean Faculty of Allopathic Medicine of Srimanta Sankaradeva University of Health Sciences (SSUHS) from candidates who fulfill the eligibility criteria as provided below. The posts are of 3 (three) years duration from the date of appointment and shall be in addition to the duties as faculty member.

Eligible Criteria:

Applicants shall be a distinguished professor having long standing experience in teaching Health Sciences pertaining to the faculty in college/institution affiliated to SSUHS.

Should possess the recognized postgraduate medical qualification from a recognized institution with a minimum of ten years teaching experience as Professor/Associate Professor in a medical college/institution. Out of which atleast five years should be as professor in a department. Preference for these appointment may be given to the Heads of the Departments.

Instruction to the candidate:

1. The applications will be accepted from **6th April, 2024 to 30th April, 2024**. The applications received after the last date mentioned above will not be entertained.
2. Application form should be accompanied with attested copies of the following documents:
 - (i) Degree/Diploma certificates, statement of marks and other certificates of the educational qualifications.
 - (ii) Certificate/s of teaching/administrative experience an evidence of MD/MS, post-doctoral research and Ph.D. guidance.
 - (iii) Evidences in support of contribution to educational innovation, design of new curricula and courses and technology-mediated teaching learning process.(Please attach certificates of attending CISP/BCME/RBCW/ACME course if any)
 - (iv) Copies of Publications, Research or Policy Papers. Minimum 10 (ten) publications indexed in NMC approved journals.
 - (v) Birth certificate/HSLC/CBSE/Adhaar Card or other Government documents as proof date of the birth.
 - (vi) Candidate called for interview will have to be present themselves at their own cost.
 - (vii) The prescribed application form may be downloaded from the University Website www.ssuhs.in
 - (viii) On verification, if it is found that the received from an applicant is faulty/false and or is based on faulty/false certificates will liable for legal action and selection will be immediately cancelled.
 - (ix) Candidates already in the service shall submit their applications through proper channel and submit NOC from the present employer.
