The result of Entrance Examination for admission into D.Pharm and B.Pharm courses in both the Govt. and Private Institutes of Assam conducted by Srimanta Sankaradeva University of Health Sciences on 08-06-2025 is declared and made available in the University website www.ssuhs.in Candidates are requested to download their score cards by logging into the application portal available in the University website using Login ID and Password created at the time of submission of application form.

Further, in pursuance of Assam Govt. Notification No.e.MER.488929/19, dated 26-07-2024, SSUHS is pleased to notify the following minimum eligibility percentile and corresponding marks in the Entrance Examination for admission into Pharmacy courses (D.Pharm and B.Pharm) for the academic session 2025-26.
