ENTRANCE EXAMINATON FOR ADMISSION INTO POST BASIC B.SC. NURSING COURSE IN THE INSTITUTES OF ASSAM FOR THE SESSION 2025

In pursuance of the Assam Gazette Notification No. MER. 206054/786 dated 07-11-2023 and Notification No. MER. 488929/19 dated 26-07-2024, the Entrance Examination for selecton of candidates for admission into **Post Basic B.Sc. Nursing Course** in the Institutes of Assam for the session 2025 is going to be held on 20-07-2025 at Guwahati. Online Application Forms shall be available on University website: www.ssuhs.in from 02-06-2025 to 30-06-2025. The distribution and reservation of seats shall be according to the directives of the Government of Assam. There is no Govt. seat for Post Basic B.Sc. Nursing Course. The online application Form must be filled up after carefully going through the instructions given along with the Form.

The requisite entrance examination fee (non-refundable) shall have to be paid by the candidates available in the online application portal. However, the confirmation of payment in the application portal will be available after 72 hours of successful payment. Examination fee is exempted for PwD (Divyang) category of candidates having disability of 40% and above.

Details of the Entrance Examination including eligibility criteria and requirements are available at the University website: www.ssuhs.in.

Admit Cards will be available online at www.ssuhs.in (application portal) from 07-07-2025 which can be downloaded after log in.

Candidates are strictly advised to keep record of the Application Number and Password used by them while submitting the online form, without which they will not be able to download Admit Cards.

DETAILS OF ENTRANCE EXAMINATON FOR ADMISSION INTO POST BASIC B.SC. NURSING COURSE IN THE INSTITUTES OF ASSAM FOR THE SESSION 2025

- 1. The Entrance Examination shall be held on 20-07-2025 (From 11 AM to 1 PM)
- 2. There shall be 1 (one) paper consisting of 50 objective type Multiple Choice Questions (MCQs) based on Indian Nursing Council (INC) prescribed GNM syllabus.
- 3. Merit shall be prepared based on the total marks obtained by each candidate in the Post Basic B.Sc. Nursing Enrtrance Examination. If two or more candidates secure the same marks in the Entrance Examination, the inter-se merit of such candidates shall be determined in order of preference as follows:
 - a. Candidates securing more marks in GNM Final Examination.
 - b. Candidates securing more marks in HSSLC or any other equivalent examination.
- 4. The minimum qualifying criteria/cut off score in the Entrance Examination of Post Basic B.Sc. Nursing Course will be as follows:
 - I. For 50% Management Quota Seats:
 - i. General (UR/EWS) 20th Percentile
 - ii. SC/ST/OBC (NCL) 18th Percentile
 - iii. Divyang 15th Percentile
 - II. For Rest 50% seats:
 - i. General (UR/EWS) 18th Percentile
 - ii. SC/ST/OBC (NCL) 15th Percentile
 - iii. Divyang 15th Percentile

The eligibility criteria for appearing in the entrance test for admission into Post Basic B.Sc. Nursing Course are as follows:

- Applicant must be a citizen of India.
- Passed the Higher Secondary or Senior Secondary or Intermediate or 10+2 or an equivalent examination recognized by the University for this purpose. Those who have done 10+1 in or before 1986, will be eligible for admission.
- 3. Obtained a certificate in General Nursing and Midwifery and registered as R.N.R.M. with the State Nurses Registration Council. A male nurse, trained before the implementation of the new integrated course besides being registered as a nurse with State Nurses Registration Council, shall produce evidence of training approved by Indian Nursing Council for a similar duration in lieu of midwifery in any one of the following areas:

- O.T. Techniques
- Ophthalmic Nursing
- Leprosy Nursing
- > TB Nursing
- Psychiatric Nursing
- Neurological and Neuro Surgical Nursing
- Community Health Nursing
- Cancer Nursing
- Orthopedic Nursing
- 4. Colour blind candidates are eligible provided that colour corrective contact lens and spectacles are worn by such candidates.
- 5. Candidate shall be medically fit.
- 6. Married candidates are also eligible for admission.
- 7. Students shall be admitted once in a year.
- 8. In-service candidates are required to upload NOC from the present employer in the online application portal and submit study leave sanction order at the time of admission to the course as this is a full time course.

9. Reservation Policy

Reservation of seats for admission in Nursing Colleges for SC/ST/OBC/EWS/PH will be as per Govt. of Assam existing norms as applicable to the College concerned.

In respect of candidates belonging to SC/ST/OBC the marks obtained in 3 core subjects shall be 40% instead of 45% for General category candidates.

Reservation for disability:

5% Disability reservation to be considered for disabled candidates with a **disability of loco-motor** to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to qualification will be same as prescribed for General category candidates.

IMPORTANT:

It is the responsibility of the applicant to furnish all information correctly. Any information given by the applicant if found to be false or any ineligibility criteria detected at any stage later on shall make him/her liable to be disqualified from the Entrance Examination with all its associated consequences.

A candidate who desires to be considered under reserve category shall have to furnish original certificate of the concerned category from the Competent Authority at the time of Counselling.

A candidate applying under PwD (Divyang) Category will have to produce applicable Certificate from the State Level Medical Board/District Level Medical Board as constituted in persuance of Social Welfare Departments Notification No. SWD.181/96/75 dated 21-06-1990.

As the form is to be submitted online, the candidates are not required to send any document to the Univrsity. All necessary verification/scrutiny of the related documents of the candidates regarding eligibility, reservation etc. will be done at the time of counselling by the concerned authority.
